30 to 40 % of municipal solid waste is bio-waste. For the calculation of fees 30 % of municipal waste is taken into account (1.000 t bio-waste/a * 0,001 €). In some cases (like implementing of bio-waste management or separate collection in countries) the fee can be increased in 3 steps (25%, 50%, 75%) in the first years.

Biowaste organisations are defined as organisations supporting the sustainable management of biowaste and the recycling of organic materials. This includes waste management organisations, compost/soil improver organisations and biogas/digestate organisations, as well as quality assurance organisations in the field of organic material recycling. In comparison to the membership type "Bio-waste organisation" (BIOO) the membership type "Non-profit environmental organisation" (NPEO) does not work specifically in the field of biowaste or organic recycling.
