The purpose of the event is discussing the supporting actions that farmers and other actors working in the rural areas need to **save organics in soil**. Organics are crucial to recover soil health, quality, and fertility. Full recovery of the soils may be achieved by adopting management and monitoring plans that aim to enhance their humus content and water retention capacity and that allow them to work as natural carbon sinks. Any integrated soil management plan should include **regular application of organic matter on the soil**. We invited panellists from the EU institutions (European Parliament and European Commission), business associations and NGOs as well as practitioners from the agriculture and vineyard sectors to discuss current status and outlook of the soils in Europe.


